## CRIMINAL DEFENCE

---

Giles has developed an impressive, varied Crown Court practice over the last sixteen years, defending in cases covering the full range of serious criminal offences, including murder, terrorism offences, conspiracy to supply Class A drugs, serious violence, arson, blackmail, perverting the course of justice, aggravated burglary and cash-in-transit robberies.

### NOTABLE CASES

#### **Murder and attempted murder**

##### ***R v H* [2022] and [2023] Bristol Crown Court**

Giles is currently representing a young person charged, alongside eight others, with murder. The case has been reported in [The Guardian](#).

##### ***R v C* [2022] Central Criminal Court**

Giles represented a young man charged with the attempted murder of his then-partner.

##### ***R v J* [2021] Ipswich Crown Court**

Giles, led by Keir Monteith QC, represented a man accused of murdering his former partner. The case was reported on [the BBC](#).

##### ***R v H* [2021] Basildon Crown Court**

Giles, led by Peter Wilcock QC, represented a man acquitted of murder during the course of a bungled burglary of a cannabis factory. The case was reported on [the BBC](#).

##### ***R v G* [2016] Central Criminal Court**

Giles was led by Peter Wilcock QC of Garden Court Chambers in this murder acquittal.

##### ***R v B* [2015] Central Criminal Court**

Giles was led by Peter Wilcock QC in this widely-reported double murder case. This case was reported by [the BBC](#).

#### **Other serious violence**

##### ***R v B* [2022] Woolwich Crown Court**

Giles represented a young music artist acquitted of a firearms offence, false imprisonment, robbery and GBH.

### ***R v B* [2019] Luton Crown Court**

Giles represented a man acquitted of offences of Section 18 GBH with intent and violent disorder. The case featured in the Channel 4 programme '24 Hours in Police Custody' and appeared in the [national press](#).

### ***R v H* [2018] Luton Crown Court**

Giles represented a man charged with Section 18 GBH and successfully argued for the case to be dismissed at half time.

### ***R v M* [2017] Wood Green Crown Court**

Giles represented a young man charged with aggravated burglary, acquitted in a trial which involved a complex legal argument.

### ***R v C* [2016] Wood Green Crown Court**

Giles represented a young man acquitted of possession of an imitation firearm with intent to cause fear of violence.

### ***R v P* [2016] Brighton Crown Court**

Giles represented a young woman acquitted of grievous bodily harm after a glassing in a Brighton nightclub.

### ***R v M* [2016] Isleworth Crown Court**

Giles represented a youth charged with conspiracy to cause grievous bodily harm after a fight at a car boot sale. After the legal argument, the CPS offered no evidence against the youth. This case was reported by [the BBC](#).

### ***R v S* [2012] Guildford Crown Court**

Giles represented a young man acquitted of a s.18 wounding following a glassing incident in a nightclub, successfully running the defence of self-defence in difficult circumstances.

### ***R v S and others* [2012] Kingston Crown Court**

Giles was led in a multi-handed armed robbery case, acting for a defendant accused of conspiracy to rob cash-in-transit vehicles.

### ***R v L and others* [2012] Snaresbrook Crown Court**

Giles acted as junior counsel in a multi-handed trial involving firearms and aggravated burglary in a case involving a novel legal argument about the admissibility of hearsay evidence in the days following the Court of Appeal's ruling in the case of Horncastle.

### **R v M [2023] Croydon Crown Court**

Giles, led by Nerida Hardford Bell, represented a man acquitted of a multi-million-pound money laundering conspiracy.

### **R v K [2019] Kingston Crown Court**

Giles represented a man charged with large-scale immigration fraud, led by Nick Wrack. The case was dismissed at halftime.

### **R v A [2015] Lewes Crown Court**

Giles acted for a man who falsely claimed that he was a fully-qualified barrister, whilst representing individuals at tribunal hearings. This case was reported by [the BBC](#).

### **R v A [2014] Central Criminal Court**

Giles acted for a man accused of 'masterminding' a £660,000 money laundering operation. This case was reported in the local press.

### **R v D [2013] Reading Crown Court**

Giles acted as junior counsel in a case involving identity and benefit fraud, spanning two decades, to the value of over £300,000. This case was reported in the national press.

### ***R v U and others* [2012] Liverpool Crown Court**

Giles represented a 38-year-old man acquitted of two counts of sexual assault of the 12-year-old daughter of his partner.

### ***R v S* [2022] Central Criminal Court**

Giles represented a woman acquitted of assisting an offender in a multi-handed murder trial.

### ***R v O* [2021] Harrow Crown Court**

Giles represented a man charged with multi-million-pound cocaine importation in this EncroChat case.

### ***R v T and others* [2019] Wood Green Crown Court**

Giles represented a man acquitted of supplying large amounts of cocaine.

### ***R v C* [2018] Swindon Crown Court**

Giles represents a young man charged with being the leading figure in a 'County Lines' operation to supply crack cocaine and heroin.

### ***R v A and others* [2018] Central Criminal Court**

Giles represented an individual charged with fail to disclose information about acts of terrorism.

### ***R v F* [2017] Isleworth Crown Court**

Giles represented a man charged with the burglary of over £2 million pounds' worth of items from Simon Cowell's house.

### ***R v M* [2015] Southwark Crown Court**

Giles represented a man charged with violent disorder arising out of the 2014 Million Mask March. The CPS offered no evidence in this case following legal argument.

### ***R v S* [2015] Isleworth Crown Court**

Giles represented a young man charged with a large-scale conspiracy to burgle houses and steal sports cars across the South of England.

### ***R v M and others* [2014] Harrow Crime Court**

Giles represented a young man accused of involvement in a large-scale conspiracy to burgle and steal sports cars across Hertfordshire. Whilst four of his co-defendants were convicted, Giles's client was acquitted.

### **R v G [2013] Guildford Crown Court**

Giles acted for a man accused of child cruelty against his grandchild. Following careful negotiation, the Crown was persuaded to offer no evidence in this case.

### **R v D and others [2013] Wood Green Crown Court**

Giles represented a father acquitted of falsely imprisoning and threatening to kill his own daughter in an alleged "honour crime."

### **R v A [2013] Southwark Crown Court**

Giles represented a man alleged to have assisted in disposing of the body of a young woman murdered by members of her family in 2006. This case had wide press coverage including in *The Telegraph*, the *Daily Mail* and the *Standard*.

### **R v H[2012] Wood Green Crown Court**

Giles represented a young man accused of robbing the BBC Home Affairs correspondent at knifepoint. This case was reported by the BBC both [here](#) and [here](#).

### **R v A [2012]**

Giles represented one of two identical twins charged with funding terrorism abroad. This case was reported by the [BBC](#).

### **R v C and others [2009] Kingston Crown Court**

In a high-profile case, Giles represented a young defendant charged with a "smash and grab" robbery of £300,000 worth of jewellery from a leading London hotel.

## CRIMINAL APPEALS

---

Giles has secured a series of excellent results at the Court of Appeal in recent years, including a successful appeal against sentence in one of the widely-reported Gaza protest cases. His work as a criminal defence barrister encompasses courts-martial work in the UK and abroad.

### NOTABLE CASES

#### ***R v Blackshaw and others* [2011] EWCA Crim 2312**

Giles represented Lorri Anne McGrane, one of the appellants in what became the leading sentencing authority for offences committed during the civil disorder in August 2011. This case was reported by the [BBC](#).

#### ***R v Askew (Martin)* [2010] EWCA Crim 2102**

Giles represented the second and third appellants in an appeal against sentence in one of the high-profile Gaza protest cases. Giles successfully argued for a reduction in sentence for the third appellant.

#### ***R v Mouad Amri* [2008] EWCA Crim 1350**

Giles successfully appealed against the imposition of a sentence of Imprisonment for Public Protection (IPP) in a case of robbery and possession of an imitation firearm.

#### ***R v McLeod* [2008] EWCA Crim 2980**

Giles successfully argued that a custodial sentence of 18 months was manifestly excessive in a case of burglary and aggravated vehicle taking.

#### ***R v Manilal* [2008] EWCA, Crim**

Giles successfully appealed against the length of an extended sentence in a case where the appellant had pleaded guilty to assaulting his three and six-year-old sons.

## BACKGROUND

---

Giles joined Garden Court Chambers in 2013. Prior to this, Giles practised at Toops Chambers having gained tenancy in October 2007 following completion of his pupillage there.

Giles previously worked at the Refugee Legal Centre, representing asylum seekers in substantive appeals before the Immigration Appeal Tribunal. He is committed to pro bono work and has worked as a volunteer at

Liberty, The Refugee Council and various legal advice centres in London.
