CONSENT ORDER

BY CONSENT, it is ordered that:-

Upon the judgments in *R (Detention Action) v SSHD* [2014] EWHC 2245 (Admin) (9 July 2014); *R (JM and Ors) v SSHD* [2015] EWHC 2331 (Admin) (3 July 2015) and *R (PU and Ors) v SSHD* (CO/678/2015, CO/747/2015, CO/814/2015) (20 July 2015)

And upon the Defendant agreeing, having regard to those judgments and to the facts and circumstances of the Claimant's case:

- (1) to withdraw her decision to refuse the Claimant's asylum and human rights claim made on 13 March 2014 and 11 October 2014 and
- (2) to reconsider the Claimant's asylum claim without regard to the asylum interview records dated 25 February 2014, 4 March 2014 and 11 March 2014 or the Claimant's withdrawn asylum and human rights decisions referred to in (1) above, with the Claimant to have 3 months to submit further submissions and evidence she wishes for the Defendant to take account in the reconsideration,
- (3) to complete reconsideration within 3 months of (2) above

IT IS HEREBY ORDERED THAT:

1. The Claimant shall have leave to withdraw her claim for judicial review, without prejudice to any private law claim in damages relating to the Claimant's detention and processing within the Detained Fast Track processes.

2. The substantive hearing date of 16 March 2016 shall be vacated.
3. The Defendant shall pay the reasonable costs of the Claimant's application for judicial review, a reasonable sum to be paid on account of costs within 28 days of the date of this Order, to be subject to a detailed assessment if not agreed.
4. The Claimant's publicly funded costs shall be subject to a detailed assessment.
